#### How sustainable cashmere is reversing land degradation in Mongolia

The United Nations has posted an example on how sustainable procurement can help mitigate climate change. In this story, GOBI Cashmere, a well-known cashmere garment company, has been sourcing cashmere in Mongolia produced in a sustainable method, including proper animal husbandry methods, maintaining water supply and pasture conditions, buying directly from herders and provides training to ensure quality standards can be met etc. (Addressing environmental, social and economic issues.)

These methods have helped mitigate land degradation in Mongolia, and improvement the local community as a whole. Perhaps just as important, GOBI is also very transparent with its procurement practice, which can be traced. Overall, this is a great example on how procurement can be done in a sustainable way. It is a good best-practice study.

# Public consultation on Scheme on Regulation of Disposable Plastic Tableware

The Environmental Protection Department (EPD) on July 9 released a consultation paper on the Scheme on Regulation of Disposable Plastic Tableware. The Scheme aims to reduce the use of disposable plastic tableware at source. The two-month public consultation will end on September 8, 2021.

The Scheme has proposed to ban the local sale and provision (including catering premises) of disposable expanded polystyrene (EPS) tableware and also to prohibit the provision of disposable plastic tableware (including oxo- & bio-degradable) for dine-in and takeaway services in two phases. Procurement should explore those non-plastic disposable tableware alternatives, e.g. paper, bamboo, soft wood, etc., available in the market to prepare the change.





#### Establish greenhouse gas reduction targets: Science-based approach

Man-made greenhouse gas emissions have continually created many unpredictable and unmanageable impacts on the change of climate. In this year, we had drought and water-rationing in Taiwan and Guangdong, extreme flooding in Mainland, both record low and high temperature in North America. Many governments, including China and Hong Kong, have committed and set carbon neutral targets. That's why hundreds of businesses – including some of our members – are setting science-based targets (SBTs), which aim to prevent the catastrophic damage that global warming could cause.

SBTs ensure a company's emissions are in line with the Paris Agreement on Climate Change, committed to prevent the worst effects of catastrophic climate change by limiting average global temperature to 1.5 degree Celsius above pre-industrial

level. SBTs are powerful way for your company to boost its competitive advantage in the transition to a low-carbon economy and to add transparency and external credibility to internal sustainability goals.

Green Council will conduct an online training course on "Establish greenhouse gas reduction targets: Science-based approach". The course will also cover the emissions from your suppliers which are always the greatest portion of your total emissions. Please do not miss this opportunity to attend, please register.
